

Information for Child Nutrition Program Administration Courses Summer 2017

We are pleased to offer the Child Nutrition Program Administration (CNPA) overview course for local school nutrition directors and managers in **three** sessions for summer 2017. We are announcing these courses early to facilitate your planning and to allow time to determine fiscal year budgetary allowances. Although designed for child nutrition personnel who have been in their positions for two years or less, the course is also open to those who would like a review of key child nutrition administration topics.

This course provides new staff with basic information on the importance of healthy meals and describes applicable federal and state regulations, thereby decreasing the risk of fiscal sanctions that can result from noncompliance. The course provides a wonderful opportunity to connect and network with fellow food services professionals. In addition, the CNPA provides a learning environment to discuss problems and identify strategies with colleagues statewide. The course provides 32-continuing education hours for Professional Standards. Due to the popularity of this course, participation is limited to one person per sponsor, as well as only to those who have not attended this course in the last three years.

- Federal and state regulations
- Procurement requirements
- Meal pattern requirements
- Fiscal systems
- Student nutrition and wellness policies
- Sanitation and food safety
- Human resources management
- Marketing practices

Registration

Registration is a two-pronged process using the Child Nutrition Information and Payment System (CNIPS). The two steps are online registration and payment. Please review the instructions below **before** starting the registration process.

Online Registration Process

- To register, obtain your agency's five digits CNIPS ID number **OR** personal user ID and password.
- Visit the California Department of Education CNIPS Training Web page https://www.cnips.ca.gov/ccqCnpTraining/training/trainingRegistration_2.aspx to connect to the CNIPS and begin the online registration process.
- To register, use your agency's CNIPS ID or personal User ID and password and follow the system prompts as shown below:
 - Program Training Available screen—select **All**
 - Available Training(s) screen—select **Child Nutrition Program Administration**
 - Available Training Location(s) screen—select preferred location
- After completing the Attendee Information and selecting the **Continue** button, a confirmation e-mail will be sent to the e-mail address provided.

Payment Process
